Photography Guidelines

Family Tree Nursery has become a very popular destination for photography. While our stores have a beautiful park-like atmosphere, we are still a private business. Photography sessions (professional or amateur) can interfere with our day-to-day business. Because of this, we ask for your cooperation with the following guidelines:

Photo Session Guidelines

- Family Tree Nursery reserves the right to refuse or suspend a session for any reason and to direct where photography will be permitted on the premises.
- Please call ahead to schedule your session. In the event of rain or inclement weather, you may reschedule your session.
- All photo sessions will pay a session fee of \$150 per hour. Session fees will not be prorated.
- Payment in full must be made by the morning of the shoot. Payment may be made by cash, check or credit card. Appropriate sales taxes will be applied.
- A signed copy of these guidelines and attached application must be returned no later than 24 hours before the scheduled session.
- Photo sessions must be scheduled during our regular business hours. Exceptions will be considered on an individual basis and may incur additional fees.
- Certain times and locations may be unavailable due to several factors including, but not limited to, business cycle, traffic flow, special events, seasonality, and weather. Sessions will not be available in April and May.
- Exceptions can be made at the discretion of management on a case by case basis.
- Photo sessions must not interfere with regular business practices or the enjoyment of other customers, or close access to any area.
- Guests should come dressed and prepared for their sessions. Family Tree Nursery restrooms are NOT to be used as changing rooms.
- All session participants must be fully clothed while on the property. Lingerie shoots will NOT be permitted.
- Do not disturb or remove plants, containers, garden accents, or any other merchandise to stage a photo.
- Photography sessions must not create any safety concerns for participants, Family Tree Nursery customers or staff.
- Do not climb on ladders, stand on benches, display pieces or tables or ride on shopping carts.
- Photographers are responsible for any damage to Family Tree Nursery property.
- Family Tree Nursery and its employees are not responsible for any loss or damages that may occur.
- Drone photography is considered commercial photography and requires a scheduled session with applicable fees.
- All session participants (photographers and subjects) will be required to sign the current version of the Family Tree Nursery Photo Session Waiver and Indemnification Agreement prior to beginning photography activity on-site.
- All session participants (photographers and subjects) shall comply will all applicable laws, rules, and regulations at all times.
